## KOSOVO



- Declared independence on 17<sup>th</sup> of February 2008
- Area: 10,908km<sup>2</sup>
- Population: 1,8 million
   inhabitants (92% Albanians, 4% Serbs, 4% others)
- Official languages: Albanian and Serbian



INSTITUTIONAL DEVELOPMENT: FROM AN AFTER-WAR EMERGENCY SITUATION TO A WELL-FUNCTIONALIZED EDUCATIONAL INSTITUTION

- Emergency phase (1999 2001)
- Transition phase (2002 2006)
- Transfer phase (2006 2007)
- Sustainability Phase (2008 2012)
- Upgrade and further development phase (2012-...)



# **EMERGENCY PHASE (1999 - 2001)**

- Department for Police Education and Development (DPED) of the OSCE Mission in Kosovo established the Kosovo Police Service School (KPSS) on 6 September 1999
- Basic Police Training was developed by OSCE MiK DPED and the US Department of Justice International Criminal Investigative Training Assistance Program (ICITAP)
- 1999: 6-week training; 2000: 9-week training; 2001:
  12-week training



# **TRANSITION PHASE (2002 - 2006)**

- End of 2003: 75% of core services at the KPSS were transferred to and operated by local staff
- Training further extended to 20 weeks
   Police School to Educational Public Safety
   Institution: training provided to Customs and
   Corrections, too
- 2005 End of transition phase: DPED of OSCE MiK proposed establishment of KCPSED
- 2006: KPSS became Kosovo Centre for Public Safety Education and Development (KCPSED)



# **TRANSFER PHASE (2006 - 2007)**

- OSCE transferred managerial responsibilities for the KCPSED to the Kosovo provisional institutions
- KCPSED conducted first line supervision, middle management, and senior management courses
- OSCE supported the KCPSED to establish the Accreditation and Certification Section to draft self-evaluation reports that would pave way for an effective accreditation process

#### Legal bases issued by UNMIK on 26<sup>th</sup> of March 2008:

- Administrative Direction no. 2008/3 Implementing UNMIK Regulation no. 2001/19 on the Executive Branch of the Provisional Institutions of Self-Government in Kosovo\*

- Regulation No. 2008/17 amending UNMIK Regulation No. 2005/54 on the framework and guiding principles of the Kosovo Police Service
- Regulation No. 2008/18 on the establishment of the Kosovo Board on Public Safety Standards and Education

# SUSTAINABILITY PHASE (2008 - 2012)

- 2008: KCPSED was established as an executive agency of the Ministry of Internal Affairs
- 2010: MolA's working group commenced drafting the new Law on KCPSED
- 2010: Administrative Instruction on Internal Organization and Structuring No. 29/2010-MIA was adopted and entered into force
- December 2011: by the new Law adopted from the Assembly of Kosovo, KCPSED was renamed into Kosovo Academy for Public Safety (KAPS) as an executive agency of the MoIA



# UPGRADE AND FURTHER DEVELOPMENT PHASE (2012 - ...)

2012 - 2014: EU-funded Twinning Project "Further Support to Public Safety Education in Kosovo", implemented by Finland and Estonia

2016 - 2019: EU-funded Twinning Project "Improved Education in Public Safety and Security Sectors in Kosovo", implemented by Finland and Estonia



# EU-FUNDED TWINNING PROJECT "FURTHER SUPPORT TO PUBLIC SAFETY EDUCATION IN KOSOVO"

- Established a 4-year Bachelor level study program on Public Safety, with branches of: Police&Police Inspectorate, Corrections&Probation, Customs and Emergency Management
- Previously was completed the legal bases (7 by-law documents), accreditation process and donation of books, with the contribution of the OSCE Mission in Kosovo, too
- International cooperation extended with similar institutional partners from Finland and Estonia





- Contribution to KAPS institute of Research and Development becoming fully functional for the benefit of all public safety agencies in Kosovo




# **CURRENT SITUATION**



- Re-accreditation 2021 2024

#### Institutional & program accreditation of vocational training and education

- Accreditation dated 12 April 2019;
- Re-accreditation dated on 24 July 2022

#### International institutional accreditation according to American standards by IADLEST, USA

- First accreditation 15 May 2018 until 2021 (116 points out of 156 in total);

- Re-accreditation on 25 August 2021 until 2024 awarded with the Award of Excellence, as the second in the world after another institution in the US.

### KOSOVO: PUBLIC SAFETY ACADEMY RECEIVES INTERNATIONAL REACCREDITATION

August 25, 2021

On August 25, the Kosovo Academy for Public Safety (KAPS) successfully completed the requirements necessary for reaccreditation from the US-based International Association of Directors of Law Enforcement Standards and Training (IADLEST). The IADLEST Accreditation Manager stated, "I wanted to inform you that the Kosovo Academy of Public Safety passed its reaccreditation. In fact, the improvements they made over the past three years yielded a score that qualifies for the highest level of IADLEST Accreditation: The Award of Excellence. The Kosovo Academy of Public Safety becomes the first of our international law enforcement academy partners to achieve such a distinction and is only the second in the world to achieve that distinction." The Kosovo institution was the first in the world to receive IADLEST accreditation: The Academy is the leader in international public safety academy accreditation; academy officials from the region and beyond have contacted KAPS for assistance as they prepare for their own IADLEST accreditation.


